If you have automatic debits taken from your bank account to pay your bills, then you already understand the PAR principle. Did you know that you can give to the church in the same way?

Using the PAR program for your offering allows you to give intentionally, proportionally and faithfully to the church, even when you are not able to be there in person.

It's easy. Just decide what you want to give each year and divide that amount by twelve. (Or, decide what you want to give weekly that by 4.33, as there are 4.33 weeks in a month. Then fill out the authorization form to get started and that amount will be transferred to the church's account each month. You can use the PAR Cards on the offering plate each week as a symbol of your gift.
